EXECUTIVE ORDER

TO: HEADS OF ALL STATE DEPARTMENTS, AGENCIES AND AUTHORITIES AND ALL POLITICAL SUBDIVISIONS AND GOVERNMENTAL UNITS OF THE STATE OF DELAWARE

RE: REALLOCATION OF STATE PRIVATE ACTIVITY BOND VOLUME CAP FOR CALENDAR YEAR 1993 AND INITIAL SUBALLOCATION OF STATE PRIVATE ACTIVITY BOND VOLUME CAP FOR CALENDAR YEAR 1994

WHEREAS, pursuant to 29 Del. C. §5091, the State's private activity bond volume cap ("Volume Cap") for 1993 under Section 103 of the Internal Revenue Code of 1986 (the "Code"), was been allocated among various State and local government issuers; and,

WHEREAS, pursuant to Executive Order Number One Hundred Ten, \$75,000,000 of the Volume Cap for 1993 which had been allocated to the State of Delaware was further suballocated between the Delaware Economic Development Authority and the Delaware State Housing Authority; and,

WHEREAS, the allocation of Volume Cap in Executive Order Number One Hundred Ten is subject to modification by further Executive Order; and,

WHEREAS, the Delaware State Housing Authority has remaining \$37,500,000 of unused 1993 Volume Cap; and,

WHEREAS, the State's Volume Cap for 1993 is allocated among the various State and local government issuers by 29 Del. C. §5091(a); and,


WHEREAS, pursuant to 29 Del. C. §5091(b), the State's \$75,000,000 Volume Cap for 1994 is to be suballocated by the Governor among the Delaware State Housing Authority, the Delaware Economic Development Authority and other governmental issuers within the State; and,

WHEREAS, the Secretary of Finance recommends (i) that \$37,500,000 of the Delaware State Housing Authority's 1993 Volume Cap be reallocated to the Delaware Economic Authority to be carried forward for use in future years and (ii) that the State's \$75,000,000 Volume Cap for 1994 be allocated equally between the Delaware State Housing Authority and the Delaware Economic Development Authority; and,

WHEREAS, the Chairperson of the Delaware Economic Development Authority and the Chairperson of the Delaware State Housing Authority concur in the recommendations of the Secretary of Finance.

NOW, THEREFORE, I, THOMAS R. CARPER, by the authority vested in me as Governor of the State of Delaware, do hereby declare and order as follows:

1. Executive Order Number One Hundred Ten is hereby amended so that of the \$75,000,000 allocation to the State of Delaware of the 1993 Volume Cap, \$75,000,000 is suballocated to the Delaware Economic Development Authority.
2. The \$75,000,000 allocation to the State of Delaware of the 1994 Volume Cap is hereby suballocated \$37,500,000 to the Delaware State Housing Authority and \$37,500,000 to the Delaware Economic Development Authority.
3. The aforesaid suballocations have been made with due regard to actions taken by other persons in reliance upon previous suballocations to bond issuers.
