EXECUTIVE ORDER NUMBER THIRTY-NINE

TO: HEADS OF ALL STATE DEPARTMENTS, AGENCIES AND AUTHORITIES, AND ALL POLITICAL SUBDIVISIONS AND GOVERNMENTAL UNITS OF THE STATE OF DELAWARE

RE: REALLOCATION OF STATE PRIVATE ACTIVITY BOND VOLUME CAP FOR CALENDAR YEAR 1995 AND INITIAL SUBALLOCATION OF STATE PRIVATE ACTIVITY BOND VOLUME CAP FOR CALENDAR YEAR 1996

WHEREAS, pursuant to 29 <u>Del. C.</u> § 5091, the State's private activity bond volume cap ("Volume Cap") for 1995 under § 103 of the Internal Revenue Code of 1986 (the "Code") has been allocated among various state and local government issuers; and

WHEREAS, pursuant to Executive Order Number Twenty-Four, \$75,000,000 of the Volume Cap for 1995 which had been allocated to the State of Delaware was further suballocated between the Delaware Economic Development Authority and the Delaware State Housing Authority; and

WHEREAS, the allocation of Volume Cap in Executive Order Number Twenty-Four is subject to modification by further Executive Order; and

WHEREAS, the State's Volume Cap for 1995 and 1996 is allocated among the various State and local government issuers by 29 <u>Del. C.</u> § 5091(a); and

WHEREAS, New Castle County has reassigned \$25,625,000 of its unallocated Volume Cap for 1995 to the State of Delaware; and

WHEREAS, Kent County has reassigned \$10,000,000 of its unallocated Volume Cap for 1995 to the Delaware Economic Development Authority and \$5,000,000 of its unallocated Volume Cap for 1995 to the State of Delaware; and

WHEREAS, Sussex County has reassigned \$12,000,000 of its unallocated Volume Cap for 1995 to the Delaware Economic Development Authority and \$3,000,000 of its unallocated Volume Cap for 1995 to the State of Delaware; and

WHEREAS, the City of Wilmington has reassigned \$12,500,000 of its unallocated Volume Cap for 1995 to the State of Delaware; and

WHEREAS, pursuant to 29 <u>Del. C.</u> § 5091(b), the State's \$75,000,000 Volume Cap for 1996 is to be suballocated by the Governor among the Delaware State Housing Authority, the Delaware Economic Development Authority and other governmental issuers within the State; and

WHEREAS, the Secretary of Finance recommends (i) that the \$26,590,000 of the Delaware State Housing Authority's unallocated Volume Cap for 1995 and the \$46,125,000 unallocated Volume Cap for 1995 reassigned to the State of Delaware by other issuers be reallocated to the Delaware Economic Development Authority for carry forward for use in future years and (ii) that the State's \$75,000,000 Volume Cap for 1996 be allocated equally between the Delaware State Housing Authority and the Delaware Economic Development Authority; and

WHEREAS, the Chairperson of the Delaware Economic Development Authority and the Chairperson of the Delaware State Housing Authority concur in the recommendations of the Secretary of Finance.

NOW, THEREFORE, I, Thomas R. Carper, by the authority vested in me as Governor of the State of Delaware, do hereby declare and order as follows:

- 1. Executive Order Number Twenty-Four is hereby amended so that of the \$75,000,000 allocation to the State of Delaware of the 1995 Volume Cap, \$10,910,000 is suballocated to the Delaware State Housing Authority and \$64,090,000 is suballocated to the Delaware Economic Development Authority.
- 2. The \$46,125,000 of unallocated Volume Cap for 1995 that has been reassigned by other issuers to the State of Delaware is hereby reassigned to the Delaware Economic Development Authority.
- 3. The \$75,000,000 allocation to the State of Delaware of the 1996 Volume Cap is hereby suballocated \$37,500,000 to the Delaware State Housing Authority and \$37,500,000 to the Delaware Economic Development Authority.

4. The aforesaid suballocations have been made with due regard to actions taken by other persons in reliance upon previous suballocations to bond issuers.
