EXECUTIVE ORDER
NUMBER: One Hundred Seven

TO: HEADS OF ALL STATE DEPARTMENTS, AGENCIES, AND LOCAL GOVERNMENTS.

RE: AMENDMENT TO EXECUTIVE ORDER NO. 54 ENTITLED ESTABLISHMENT OF AN INTERAGENCY COUNCIL ON THE HOMELESS FOR THE STATE OF DELAWARE.

WHEREAS, Executive Order No. 54 approved April 15, 1988, established the Delaware Interagency Council on the Homeless; and

WHEREAS, pursuant to Executive Order No. 54 the administrative responsibilities related to the Council were housed within the Department of Community Affairs; and

WHEREAS, subsequent to the enactment of Executive Order No. 54, the Department of Community Affairs was dissolved and certain of its functions absorbed within the Department of Health and Social Services; and

WHEREAS, there is a need to reduce the number of representatives on the Council in order to render it more functional; and

WHEREAS, it is beneficial to include within the Council membership a representative for the shelter providers from each county; and

NOW, THEREFORE, I, Michael N. Castle, by virtue of the authority vested in me as Governor of the State of Delaware, do hereby declare and order as follows:

1. All provisions of this Executive Order shall take effect immediately.

2. Executive Order No. 54 is hereby continued in full force and effect subject to the modifications made by this Order.

3. Executive Order No. 54 is hereby amended as follows:

A. Delete the phrase "and a private agency" as it appears at the end of the third WHEREAS, clause on page 1;

B. Delete the phrase "Department of Community Affairs/Division of Community Services (DCA/DCS)" as it appears in the fourth WHEREAS, clause on page 1 and substitute in lieu thereof the phrase "Department of Health and Social Services/Division of State Service Centers";

C. Strike the phrase "Department of Community of Affairs" as it appears in paragraph two on page 2 and substitute in lieu thereof the phrase "Department of Health and Social Services";

D. Strike the phrase "The Department of Community Affairs" as it appears in paragraph 3.1. on page 2 and substitute in lieu thereof the phrase "Department of Health and Social Services";

E. Strike the phrase "The Budget Office" as it appears in paragraph 3.2. on page 2 and substitute in lieu thereof the phrase "The Delaware State Housing Authority";

F. Strike paragraph 3.3 and 3.4 as they appear on page 2 in their entirety;

G. Strike paragraph 3.10. in its entirety and substitute in lieu thereof "Three representatives from Emergency Housing Service Providers (The Secretary shall designate a representative from each county; and);

H. Strike paragraph 3.11 in its entirety and substitute in lieu thereof "Private Real Estate Management that targets low income housing.";

I. Redesignate all subparagraphs in paragraph 3 on page 2 in accordance with the above amendments.;

J. Add a new paragraph 4 to read as follows:

"The Council Chair shall be one of the representatives from the Emergency Housing Service providers and shall be appointed by the Secretary of the Department of Health and Social Services;"

K. Redesignate the remaining numbered paragraphs.
