EXECUTIVE ORDER

TO: HEADS OF ALL STATE DEPARTMENTS AND AGENCIES

RE: AMENDMENT TO EXECUTIVE ORDER NUMBER ONE REQUIRING FINANCIAL  
DISCLOSURE FOR CERTAIN STATE OFFICIALS

WHEREAS, Executive Order No. 1 was duly signed by the Governor and attested to by the Secretary of State on January 18, 1977; and

WHEREAS, Executive Order No. 1 established requirements of financial disclosure for certain state officials; and

WHEREAS, the effective date for the first annual filing requirement was delayed until April 30, 1977 so that the interim filing pursuant to Executive Order No. 1 required of various appointees might be used to identify ambiguous, impractical or over-broad provisions contained therein; and

WHEREAS, Executive Order No. 1 should now be amended to eliminate or clarify problem areas so identified so that those who are required to disclose may have ample time in which to do so prior to the April 30, 1977, filing deadline.

NOW, THEREFORE, I, Pierre S. du Pont, IV, by the authority vested in me as Governor of the State of Delaware, do hereby declare and order that Executive Order No. 1, dated January 18, 1977, shall be and the same is hereby amended as follows:

1. Amend Subparagraph 1 (c) by inserting immediately after the word "practice" and before the word "of" the phrase ", without reference to the identity of individual clients served," so that the amended paragraph shall read as follows:

"(c) The name, address, and type of practice, without reference to the identity of the individual clients served, of any professional organization in which the person reporting or his spouse is an officer, director, or partner, or serves in any advisory capacity, from which income of \$1,000 or more was either derived during the preceding calendar year or might reasonably be expected to be derived during the current calendar year;"

2. Amend Subsection (i) of Subparagraph 1 (d) by inserting immediately before the word "Any" beginning said subsection the phrase "unless otherwise identified in answer to subparagraph 1 (c) above,", and by changing the "A" in "Any" to lower case, so that subsection (i) shall now read as follows:

"Unless otherwise identified in answer to Subparagraph 1 (c) above, above, any income or services rendered, (other than from the State of Delaware) exceeding \$1,000;"

3. Amend Subsections (iv) of Subparagraph 6 (a) by striking said subsection in its entirety, and substituting in lieu thereof the following:


"(iv) Any individual employed in the Executive Branch of the State whose annual compensation from the State of Delaware exceeds \$20,000, excluding personnel of the various public school districts, institutions of higher learning, and the Delaware National Guard, excepting the Adjutant General;"

4. Amend Subsection (v) of Subparagraph 6 (a) by striking said subsection in its entirety, and inserting in lieu thereof the following:


"(v) Any other managerial, supervisory, quasi-judicial, fiduciary or rule making personnel, including appointed members of Boards and Commissions within the Executive Branch, as the Governor or the various departments heads shall, as their authority appears, designate in writing."
