261 Legal documents issued by or filed with the Court for cases appealed from the Court of Common Pleas, Supreme Court, Court of Chancery, Superior Court, and the county land offices.

270 Records include writs of error, citations, summonses, attachments, transcripts, decrees, praecipes, depositions, recognizances, and trial lists. Entries on writs of error show the court where the possible error occurred, names of plaintiff and defendant, date of document and date issued, names of court clerk and attorney, date served by sheriff, sheriff's signature, and court term and case number. Entries on citations show court term, name of person being cited to appear in court, date to appear, name of complainant, court from which appeal is made, name of plaintiff and defendant, date of citation and date issued, names of the attorney and court clerk.

Entries on summonses and subpoenas show names of people summoned, date to appear in court, names of plaintiff and defendants, date of summons, and signature of the court clerk. Entries on attachments show court term, names of plaintiff and defendant, court decrees, who or what is to be attached, conditions of the attachment, date, and signature of the court clerk. Entries on transcripts show copies of court documents from the lower court that heard the case. Entries on decrees show court term, name of the plaintiff and defendant, court appealed from, date case heard, decision of the court, and signature of chief justice.

Entries on precipes show names of plaintiff and defendant, court from which appeal was made, name of court clerk, date, action requested, and name of person requesting the action taken. Entries on depositions show the name of person giving evidence, transcription of testimony, and signature of person giving evidence. Entries on bonds and recognizances show court term and case number, names of persons being bonded and surety, amount of bond, date of bond, date approved, signatures of witnesses, court clerks, and judge. Entries on trial lists or causes for argument show the scheduled court date; case number; names of attorneys, plaintiffs, and defendants; date of list; signature of court clerk. Some may contain notations if the case was dismissed or continued. Also included are plots from cases involving land disputes or partitions.

Notable cases include those involving the Harlan & Hollingsworth Co., Jackson & Sharp Co., Blackbird Creek Marsh Co., Philadelphia, Wilmington, and Baltimore Railroad, Philip Reybold, and Wilmington and Western Railroad. Also included is a deposition relating to Presley Allee's, clerk of the Court of Errors and Appeals, record-keeping practices.
