261 Applications from individuals requesting license to carry a concealed deadly weapon, commonly called gun permits.  
270 Files include petition of applicant, recommendation list of citizens, affidavit of publication, attorney generals notification letter. Petition shows name and hundred of representative district of applicant, comments on character background, occupation and address of applicant, date of approval, signatures of Superior Court Justice and applicant. List of citizens shows election and representative district numbers county name and age of applicant, signatures and address of citizens vouching for character of applicant, date and signatures of prothonotary and applicant. Affidavit of publication shows name of newspaper date and name of manager giving sworn statement of publication of weapons application, name of applicant, purpose of application, date notice published, signature and job title of newspaper representative, date and signature of notary public. Statement includes publication notice affixed to document. Attorney General's notification letter shows date, to whom in prothonotary's office sent, name of applicant and purpose for obtaining license, attorney general's office opinion to deny or offer no objections to license, and signature of representative of attorney general's office. Reverse side of some documents show year and application for gun permit and FBI identification form. Application for gun permit shows name, date, and place of birth of applicant, citizenship, occupation, employment, purpose of requesting permit, former military service, ownership of a sidearm, if sidearm registered, have ever been arrested, ever denied a permit, permits held in other states, date and signature of applicant. FBI identification form show name, sex, race, height, weight, date of birth, hair and eyecolor, address, place of birth, citizenship of applicant. Date fingerprinted, official taking fingerprints signature, sample of fingerprints signature, sample of fingerprints, ID number, and address of individual contributing information (State Police). Files are not maintained in the office as long as applications are renewed and then transferred when time allowed for renewal has expired. First time approved applicants were required to renew their license after the first two years. Renewals afterwards were every three years.
