 State Museums (DSM). The Archives (DPA) holdings consist mainly of
 photos of documents and records in the Archives, views of the Hall of
 Records building, Records Center construction, new archives building
 construction, records storage and destruction, staff, and various
 Archives activities.

The Museum (DSM) holdings contain the following headings: State Museum
 Accessions, Buildings, Exhibits, and Reference; Dickinson Mansion
 Furniture, Landscape, Library, and Reference; Zwaanendael Museum
 Building and Exhibits. These photos were taken to document museum
 holdings, activities, construction, and exhibits.
