Included generally with the reports were the inquisition, depositions of witnesses, and the power of attorney for the collection of jurors and witnesses fees. Inquisitions show date and place of inquisition, names of coroner, deceased and jurors and witness(es) summoned, date and cause of death and signatures of coroner, jurors and witness(es). Depositions show name of witness, testimony presented, signatures of witness, and date of deposition. Power of attorney for the collection of jurors and witness fees show name of coroner empowered to collect fees, name of deceased in inquisition taken and signatures of coroner, jurors and witnesses.
