Alexander Johnson's docket also includes names of garnishee and date of issuance of execution. Execution dockets included are those of Richard Harrington (1820-1821, 2 volumes), William Burton (1830-1834), Robert W. Reynolds (1834-1836), Alexander Johnson (1843-1845), Samuel Hagardine (1871-1874), Amos Cole (1891-1893), Robert G. and Alfred C. Dunn (1893-1895), Edward Baker (1905-1907), J. B. Raughley (1911-1912), W.S. Smith (1913-1915), and C.W. Graham (1921-1922).

The Raughley and Smith volumes include names of litigants, type of order or writ issued for execution, date of issuance, fees charged, amount of debt, mileage traveled in performance of order, specific actions taken by sheriff, and occasionally, notations in red documenting final resolution of orders. Also kept in the record book was a record of liens from the prothonotary, the clerk of Chancery, etc. The Raughley docket also contains a list of sales. Entries on the list include the names of the constable and the defendant(s) and the time and place of sale. This volume also includes a commitment list to the New Castle County Workhouse.
