include specific easements of city regulations, resolutions showing
appreciation to retiring public officials, new maintenance projects in
city parks, emergency appropriations, fixing tax rates, sale of bonds,
corrections in the tax office, municipal elections, payment of curb and
paving liens, exemptions from taxation, and repeal of ordinances and the
initiation of an investigation into the intoxication of a former Council
clerk. Series also contains some correspondence concerning resolutions
passed or presented, annual reports, audits, appraisals, studies,
capitol improvements, development plans, and ordinances. Selected
subjects include the 911 Communication Center, desegregation of schools,
river front study, homesteading, Model Cities, Marine Terminal and 350
Anniversary of Swedes Landing. Two boxes are non-legislative
