March 14, 1811.

PETITION OF PHILEMON GREEN.

To the Honorable the Senate and House of Representatives of the State of Delaware.

The Petition of Philemon Green Collector of Military fines in Murderkill Hun-

dred in Kent County for the year 1808—respectfully represents

That your Petitioner returned to the Field officers of the Regiment of his Said District the persons whose names are contained in the list hereto subjoined as delinquents or persons from whom the fines imposed could not be collected—that the Said Officers directed that legal proceedings should be instituted against them & their inability to pay more satisfactorily ascertained before they could allow the same—in consequence whereof your Petitioner took such proceedings, whereby costs to the amounts respectively annexed to their names was incurred for which your Petitioner is now unable to obtain indemnity but by Legislative interposition.

He therefore prays your Honor to take his case into consideration and grant him an appropriation for the costs so incurred,

And your Petitioner will pray &c.
