paper in hands of Sec of Trustees

Sussex Methodist Episcopal  
Wilmington Conference. Washington Area  
Sept 1785

Organized 1785. Services held in private homes until  
first building was erected about 50 yards north of present building  
in 1785. Second church built in 1838 and was opposite present  
side on Maryland side. Present Church 1874. It was improved  
in 1915 and in 1937. It is a one story frame structure. First  
settled clergyman - Rev L. H. Webster - 1884 - 90
