Added to. And be it enacted That it shall
not be lawful for the Levy Court
of Sussex County to lay any Rate
or Charge on the People of that Coun-
ty for the purchasing the Land
aforesaid, erecting the Court House
or Prison thereon or finishing the
same other than such additional
improvements as they may think
proper after the persons aforesaid
shall think it fitting for the recep-
tion of the Court aforesaid.

And be it enacted That every An-
nual and other Election for the choice
of Representatives or Representative
in the General Assembly, the Sheriff
and Coroners to be held in said ^{County of} Sussex
shall hereafter be holden and kept
at the Court House herein directed
to be built as soon as the same is so
far finished that they may be

conveniently held there and that
untill the said Court is so far finish-
ed the said Elections shall be held
at the House of James Pettyjohn in
Broadhill Hundred any Law usage
or Custom to the contrary notwith-
standing.
