HB 321 — An Act authorizing the Levy Court of Sussex County to appropriate county moneys to Slaughter Beach Volunteer Memorial Fire Company for the maintenance of an ambulance. Introduced by Messrs. Harrington, Brown. Referred to Committee on Government Operations.
