Witnesseth, That the said parties of the first part, for and in consideration of the sum of Five hundred dollars, current lawful money of the United States of America, unto them well and truly paid by the said party of the second part, at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, aliened, enfeoffed, released, conveyed and confirmed and by these presents do grant, bargain, sell, alien, enfeoff, release, convey and confirm unto the said party of the second part, its successors and assigns, All that certain lot, piece or parcel of land, situate, lying and being in said town of Georgetown, County and State aforesaid, and fronting on Market Street in said town adjoining other lands of the said Wilbur F. Tunnell and others, containing Thirteen thousand, Six hundred and fifty (13,650) square feet of land more or less.
