It was comprised of Edward W. Wilson, Daniel Cowgill, and Ezekiel Cowgill, who served on the board on and off during the mid-1800s. The trustees ultimately answered to the Preparative Meeting of Friends in Little Creek, who funded the school from their Colored School Fund.

The school was governed by a board of trustees, which operated under the direction of the Preparative Meeting of Little Creek. There is also a detailed architectural drawing of the schoolhouse, with dimensions and the inside layout. Ezekiel Cowgill, who served as a trustee on the board for the school and the treasurer for the Preparative Meeting, was the primary recipient of the invoices and bills generated by the school.
